



- 9-hole composite drilling test completed in September 2017; results compare very favorably to 7.8% zinc (over 7mn tonnes) mined previously at Daniel's Harbour; NI 43-101 report underway
- Adjacent claims are primarily owned by Altius Minerals Corp (CAD 500mn market cap)
- Dr. Gerald Harper (CEO) and and Larry Quinlan (President) have strong mining industry experience



### 52% of the world's first identification based blockchain



#### **INVESTMENT THESIS**

- Blockchain Evolution has developed Evolvechain, the world's first identification based blockchain – addressing a major constraint to the mainstream adoption of distributed ledger technology.
- Unlike all other blockchains, which are based on anonymity, EvolveChain is based on each participant on the blockchain being identified (per banking KYC norms), and acquiring a unique eKYC-ID, before the user can transact with others on the blockchain.
- Each participant's confidential personal information is kept private and secure. The unique eKYC-ID allows the participants to access only their own profiles, which they use to transact with others on the blockchain. As a result, an identifiable record of transactions across the ecosystem is recorded on the blockchain while maintaining the confidential KYC information of each participant in a secure environment.
- This eKYC-ID is the key extending ID-based blockchain solutions across multiple sectors in industry and government (select examples in subsequent slides)
- Blockchain Evolution is a team of experienced global professionals, led by Danny Wettreich (CEO), and Nilam Doctor (CTO), developing the market for these applications in the UK, US, India and Canada




# 52% of a Social 3.0 platform where users own and control access to their data; on an ID-based blockchain



#### **INVESTMENT THESIS**

- Widespread backlash to major social networks 'selling' user data without their permission
- Exploiting the absence of suitable alternatives, Facebook leadership response to user ire was to suggest that users need to pay Facebook to keep their data private
- Compelling case for a user owned and user accesscontrolled platform with an economic model that rewards the willing users for engaging with advertisers – by their own choice

# 100% of a provider of blockchain based medical confidentiality systems to the healthcare sector



- Recording and storing patient data on an identification based blockchain represents the future of healthcare recordkeeping
- Greenbank has created Medik Blockchain as a wholly owned subsidiary to create a custom designed Medik eKYC-ID blockchain solution, to ensure patient data confidentiality
- Medik Blockchain has commenced discussions with the Government of India with regard to the utilization of Medik's eKYC-ID blockchain as a core part of India's new healthcare program. Medik is in further discussions to establish one or more pilot schemes with Indian state governments at a local level to demonstrate the viability of our healthcare blockchain technology.
- Medik Blockchain will pay Blockchain Evolution Inc a 5% license fee on all revenue generated by Medik Blockchain; Blockchain Evolution Inc is a 52% owned portfolio company of GreenBank, and owns the world's first identification based blockchain
- The Medik Blockchain team is led by Danny Wettreich (CEO), and Nilam Doctor (CTO), and has its technology operations based in India







# 100% of the developer of a blockchain based digital information system for the cannabis industry



- Cannabis Blockchain is addressing the need for a safe and secure fully identified tracking system to maintain an ecosystem-wide record of transactions from the cannabis grower to the consumer
- The Cannabis Blockchain solution has three core stakeholders:
  - Consumers: Each consumer is required to provide a verified Know Your Client ("KYC") identity to transact with the other participants on the Cannabis Blockchain. This includes transactions with suppliers, other consumers and the government.
  - Suppliers: Each supplier is required to provide a verified KYC identity to transact with the other participants on the Cannabis Blockchain, including other suppliers, consumers and the government. Suppliers, including intermediary sellers, will interact with the blockchain based inventory management system which will track the supply-side value chain for each specific product.
  - Government & Regulators: The Cannabis Blockchain will include a feature to generate seller/buyer transaction reports to be used for filing tax returns. Further, a specific audit trail will also be provided upon request by governmental authorities and regulators.
- Using Cannabis Blockchain, it will be possible to efficiently track the entire value-chain journey from source of product until the point of purchase, across the cannabis industry, which is of significant value to all the stakeholders.
- The Cannabis Blockchain team is led by Danny Wettreich, Chairman and Nilam Doctor, CTO

- VFG represents many major insurance carriers, and will seek to open branch offices in areas with a high concentration of US military bases
- It's insurance product portfolio includes whole life, term life, universal life, indexed universal life, annuities, final expense, health, and Medicare
- Veterans Insurance has also commenced with other insurance agency acquisition candidates
- Veterans Insurance is led by David Lonsdale (Chairman), and Nick Goodwin (CEO) a former officer in the US Army who served during the Afghanistan and Iraq conflicts





# 19% of a digital-age financial media and communications company



- Inside Bay Street is an online portal that offers dissemination of company news by way of press releases, research reports and commentary which is distributed to brokers, investment dealers, and investors
- The platform also provides exposure to small cap companies in its Featured Companies section
- It's website is currently being modified and upgraded to add features that will
  enhance the portal in order to attract a larger user base of investors and small cap
  growth companies, and it will re-launch in the near future
- The roadmap for the platform includes
  - Company news, features, commentary and research
  - Coverage of all the small cap companies listed on the Canadian Securities Exchange
  - Expansion of the platform to include internet business radio and OTT internet television
- Inside Bay Street has a team based across North America and India, and is led by Gaurav Singh (CEO)










# 14% of a mobile-first platform that integrates social search, discovery and communication

- Envisioned as a 'super-app' that is expected to replace multiple apps currently used by the user, enhancing the overall user experience and enabling deeper analytics and better targeted push services.
- Slabdeck's executive team is based in North America and the technology operations based in India





# 12% of a worldwide online 24-hour 'Know Your Customer' identification verification process



- KYC Global provides a world-wide, low-cost, online Know Your Customer (KYC) service, at no cost to the consumer
- KYC Global is the exclusive online KYC process used by GreenCoinX, the world's first identifiable crypto currency
- The verification process is conducted with the highest level of security and comprises the upload of a copy of a passport or other government identification document, driving license, social security or tax number, utility invoice, and a photo of the user's face next to the user's government identification document open at the photo page – all completed in 15 minutes
- KYC is a necessary requirement by regulators and businesses, in an increasingly digital-first environment – and represents a rapidly growing market
- KYC Global is led by Mark Wettreich (CEO) with a global team spanning the US, Canada, Spain and India.





# 10% of a Toronto based transfer agency focused on public companies listed on the CSE



- Reliable provides stock transfer services for small cap public companies at competitive rates
- Services include processing of transfers, shareholder reports, obtaining CUSIP and ISIN numbers, acting as escrow agents, acting as scrutineers for shareholder meetings, providing stock options and warrant services, shareholder mailing services, and processing treasury directions
- Low overhead structure so it can provide such transfer agency services at very competitive rates
- The Reliable Stock Transfer team is led by Danny Wettreich (Chairman), Mark Wettreich (President), and Gary Johnston (Vice President)
- Reliable Stock Transfer is a strategic investment for GreenBank Capital Inc., and facilitates transfer agency functions for all of its portfolio companies

- It has featured as a part of the Asian Games since 1990, with India winning every Gold medal since
- It is the second most viewed sport in India, after cricket, attracting 430 million television viewers during the 2014 inaugural televised season of the Pro Kabaddi League
- The Kabaddi Games platform is currently in early beta form, and will be completed over the next few months prior to a launch targeted in the summer of 2018
- The Kabaddi Games team is led by Sarbjit Singh (CEO), with technology operations based in India

- Minfocus Exploration Corp (TSXV: MFX) is a publicly listed mineral exploration company with multiple mining assets across Canada

- Gander Exploration is a private mineral exploration company with copper and gold properties in Newfoundland
- The principal property is Cripple Creek Property in Newfoundland, comprising 65 claims located 25km north of the town of Gander.
- Between 2011 and 2013 Capstone Mining Corp (TSX:CS) completed airborne geophysical, soil sampling and mapping surveys on the Cripple Creek Property, as well as a 10-hole drilling program in 2013
- The highlights of the drilling program were 9.28m of 2.98 copper; 3.6m of 4.74% copper and 0.16 g/t of Gold
- The Gander Exploration team is led by Larry Quinlan, CEO
